

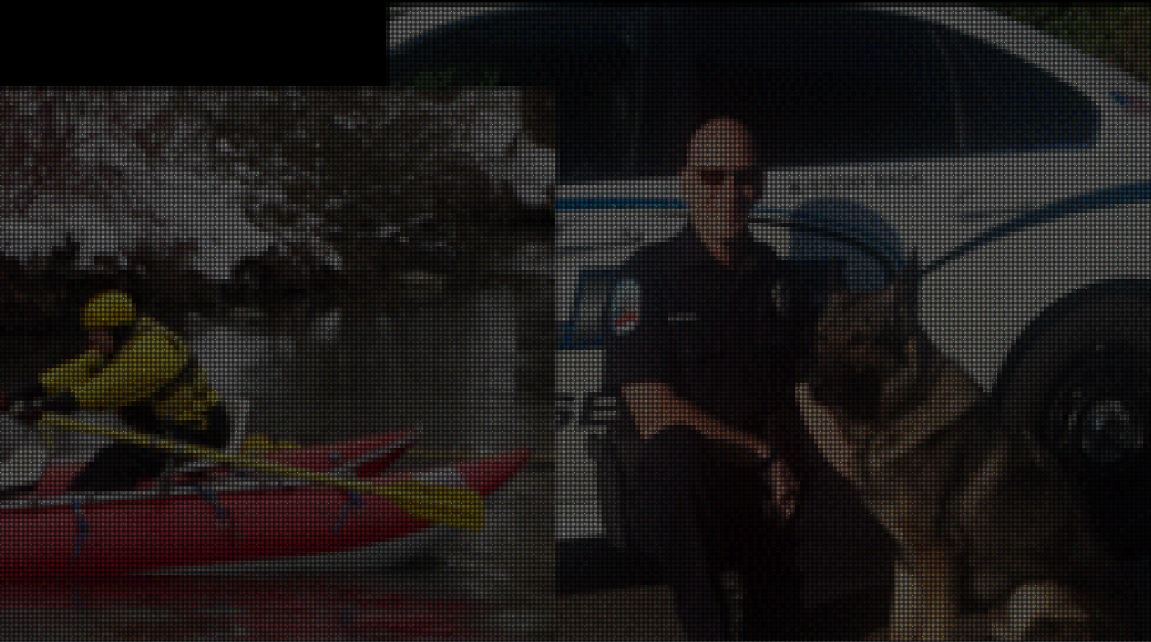

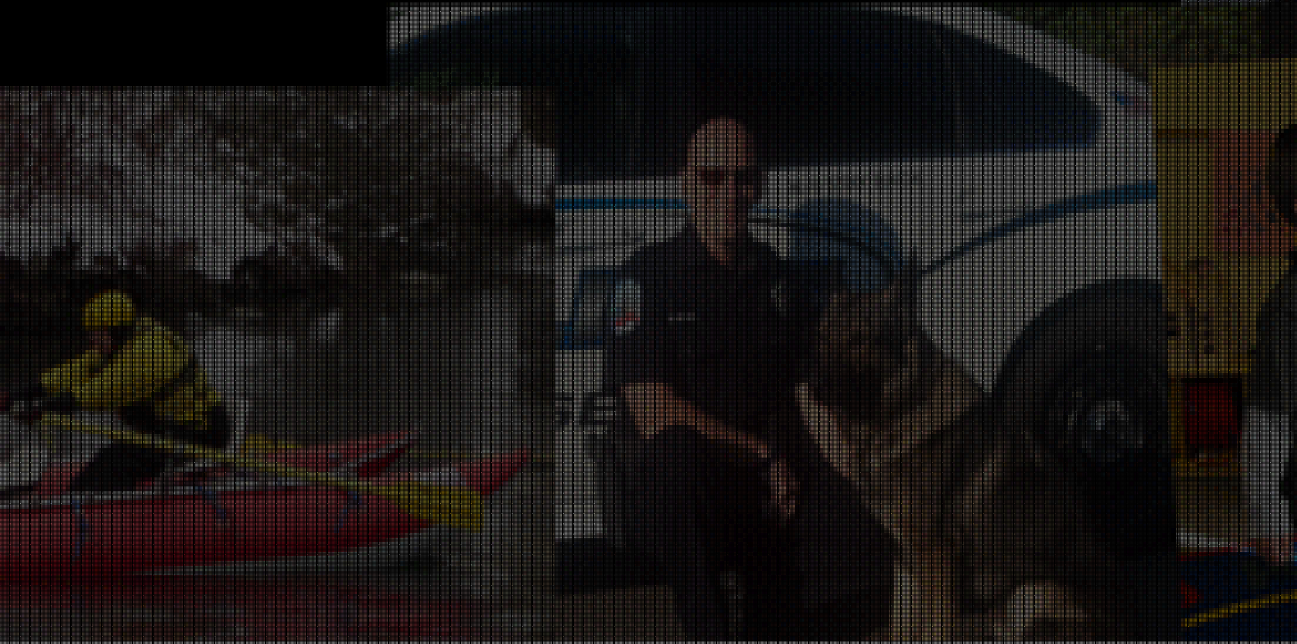

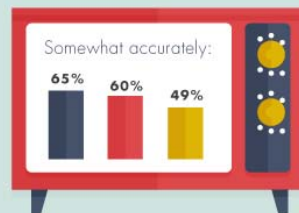

COST AS A FACTOR IN HIRING A LAWYER

Percent that say it's an important factor:



FIRST WORD THAT COMES TO MIND WHEN YOU READ THE WORD "LAWYER":

- 33% said words like *Help*, *Smart* and *Defender*
- 17% said words like *Dishonest*, *Cheater* and *Shark*
- 21% said words like *Money* and *Expensive*
- 29% said neutral words
