MESSAGE FROM THE CHAIR

APRIL 2014

As we wind down on the 2014 Legislative session, we appear to be on our way to accomplishing a couple of things, but not able to meet a very important objective of closing some post-retirement loopholes. This is both disconcerting and disappointing given that the Washington State Senate had the opportunity to pass the corrective legislation (researched and recommended by the Board) and chose not to move the legislation. HB 2479 closed loopholes that currently allow a LEOFF 2 member to collect a LEOFF pension while still working as a law enforcement officer or fire

fighter. The bill was pulled from the Rules committee by Senate Democratic Leader Sharon Nelson (D-34), making it eligible for the a vote by the entire Senate but the Majority Coalition Caucus chose not to bring it up for a vote.

Why is this important? Because the LEOFF Plan 2 board has gone to great lengths to manage our pension plan responsibly. Part of the responsibility is the maintenance of the plan's reputation. We have been diligent about contribution rate stability; we have created an additional funding mechanism (see another disappointing legislative development on page 2); and we continue to maintain extremely prudent fiscal policies. It is no accident that LEOFF Plan 2 is the "best funded state-wide defined benefit plan in the country." We are very proud of our accomplishments and the reputation that we have earned, but we also know how fleeting that can be.

We have all read sensationalized stories about potential pension abuses in Washington state and throughout the United States. LEOFF Plan 2 has passed legislation and developed policies that have provided sound best practices and effective management of the plan. When issues arise, the Board is quick to rectify any ambiguities or inadequacies in the statute, which we attempted to do with HB 2479. Public perception can deal a mighty blow to the reputation of any agency and pensions are easy prey in the new budget debate that pits corporate tax incentives versus the funding of expressed assurances to retirement plan commitments. One should certainly question the motives of elected officials who choose to maintain poor public policy when the solutions are on their doorstep.

LEGISLATIVE UPDATE



State Operating Budget Bill

Making 2014 Supplemental Operating Appropriations (ESSB 6002)

The operating expenses of state government and its agencies and programs are funded on a biennial basis by an omnibus operations budget adopted by the Legislature in odd-numbered years. In subsequent legislative sessions, a supplemental budget is adopted, making various modifications to agency appropriations. State operating expenses are paid from the state general fund and from various dedicated funds and accounts.

The 2013-15 biennial budget does not change contribution rates set by the LEOFF Plan 2 Retirement Board, and did not include an alternate revenue payment.

Board Bills

Correcting the Expiration Date of the Definition of Fire Fighter (HB 2456)

Eliminates the expiration date on the statutory provision in the LEOFF definition of fire fighter that includes emergency medical technicians (EMTs). This continues EMTs eligibility for LEOFF membership.

• Signed by the Governor 3/28

Creating an Optional Life Annuity Benefit for LEOFF Plan 2 Members (SB 6201)

Allows LEOFF Plan 2 members to roll over funds from certain tax-qualified plans to purchase a life annuity from the LEOFF Plan 2 trust fund at the time of retirement.

• Signed by the Governor 3/27

Career Change (HB 2479/SB 6397)

This bill would restrict the ability of a LEOFF Plan 2 retiree from continuing to receive their pension while employed in a position that performs primarily LEOFF duties but is not LEOFF eligible. An example of this type of position would be a less than full-time police chief or fire chief.

DEMOGRAPHIC EXPERIENCE STUDY RESULTS EXPECTED LATER THIS YEAR

Every six years, the Office of the State Actuary (OSA) conducts a Demographic Experience Study comparing the current demographic assumptions to the actual experience of the plan. This is prepared to determine if any adjustments are required to ensure our assumptions remain reasonable. The main demographic assumptions are:

- Life expectancy
- Retirement rate
- · Disability rate
- Service-based salary increase

These assumptions help estimate when benefits are paid, how much is paid, and how long they're paid for. These estimates are used to set contribution rates as well. The important thing to remember about these demographic assumptions is that any changes made to them do not change the actual cost of benefits, they simply change when the costs are accounted for.

The 2007-2012 Experience study is set to be released later this year, with OSA's presentation of their findings to the LEOFF Plan 2 Board scheduled afterward. Any recommended changes from OSA are heard and voted on by the LEOFF Plan 2 Board before the assumptions are approved into the plan.
