1. Legislative Update

Jacob White, Senior Research and Policy Manager gave a legislative update to the Board. Friday is the fiscal cutoff date for bills.

LEOFF 2 Board Bill

No-cost Interruptive Military Service Credit (HB 1007 | SB 5296) – The House version has passed out
of the House and has been referred to Senate Ways and Means. The Senate version has passed out of
Ways and Means and is awaiting floor action in the Senate.

Other Bills of Interest

- Ensuring Promoted Fire Fighters Remain in LEOFF 2 (HB 1279) Had a public hearing in Senate Ways and Means and is scheduled for Exec on Friday. No action taken in the House yet.
- Concerning Flexible Work for General and Limited Authority Washington Peace Officers (HB 1413 | SB 5424) This would allow for part time general authority and part time limited authority law enforcement officers to be eligible for LEOFF 2. Senate version has been scheduled for a hearing today

and is already scheduled for Exec session on Friday. An indeterminate fiscal note has been completed by the State Actuary's Office. The House version passed out of the policy committee but has not been scheduled for action in Appropriations.

- Allowing Tribal Law Enforcement Officers to Join LEOFF 2 (HB 1481) Has passed out of the fiscal committee and the House and has been referred to Senate Ways and Means.
- Creating an Ombudsman at DRS (SB 5625) Received a public hearing in Ways and Means but has not been scheduled for executive action.
- Allowing Members Separated Due to Vaccination Mandate and Rehired to Purchase Service Credit (HB 1814) Did not receive a hearing.
- 2023-2025 Operating Budget (HB 1140 | SB 5187)

2. Administrative Update

Executive Director Steve Nelsen gave an administrative update to the Board.

Outreach Activities

Both the WSCFF and WACOPS had their legislative conferences and Director Nelsen was invited to speak and answer questions.

FOP has a Legislative conference coming up and Director Nelsen may be giving an update but it is not confirmed yet.
