Sarah White, Benefits Ombudsman gave a comprehensive presentation on survivor purchase of service credit for authorized leave of absence. Only members may purchase service credit for unpaid, authorized leaves of absence unless the member dies while performing uniformed service for the United States. - Propose legislation to allow survivors to purchase service credit on behalf of deceased members for unpaid ALOA
