Board Endorsed Bills:

<u>HB 1349 / SB 5306</u> – Concerning the purpose of pension service credit for authorized leave of absence. The house bill was exec'd out of Senate Ways and Means and is in Senate Rules. The Senate bill was exec'd out of House Appropriations and is in House Rules

Bills of Interest:

<u>HB 2034</u> – Concerning termination and restatement of LEOFF Plan 1. This bill had a hearing in House Appropriations and has not been scheduled for executive session yet.

<u>SB 5085</u> – Concerning three of Washington state's closed retirement plans. This bill had a hearing in House Appropriations and has not been scheduled for executive session yet.
